I hereby acknowledge that I am voluntarily allowing Casitas staff to inspect my vessel for participation in the 10-Day Quarantine Program, including air flushing any areas that may contain unseen water, and hereby indemnify and hold Casitas, its officers, directors, staff and volunteers, harmless of and from any and all liability for any damage caused during, or as a result of, the inspection.
2. If a Tamper-Proof Kit is purchased, I hereby agree:
 - (a) That the kit is non-transferable and non-refundable.
 - (b) That I am solely responsible for the condition of the kit.
 - (c) That if, at any time, in the sole discretion of Casitas staff, it is determined that the cable, lock or any portion of the Tamper-Proof Kit is no longer viable, and if I wish to continue to participate in the 10-Day Quarantine Program, I will immediately purchase a new kit.

For customers who choose to complete the 10-Day Quarantine Period in a designated assigned space on the Santa Ana or Coyote Ramps, the signature below indicates that the customer acknowledges and accepts that Casitas shall not be liable for any injury to any person, or any damage to any property, or any loss arising out of the use of the space and customer shall indemnify Casitas against such liabilities. Customer is advised to maintain insurance on the vessel for any losses. In addition, customer acknowledges that the vessel will be parked in an area that is not fenced or gated and agrees to accept the conditions as provided.
