To all prospective bidders on the Work titled:  
Ventura Street Water Main Replacement (Specification No. 18-404).

Item AD2-1            Cover Sheet

Replace the cover sheet with the attached cover sheet.

Item AD2-2            Part A: Notice Inviting Bids

Replace first paragraph on page 9 with the following paragraph:

Sealed bids for the above referenced project and specifications will be received by the Casitas Municipal Water District up to **2:00 p.m. on Wednesday June 12, 2019** at the office of the District, 1055 Ventura Avenue, Oak View, California, 93022, at which time they will be opened and publicly read aloud. Each bid shall be made out on a form to be obtained from the Casitas Municipal Water District. Each bid must be accompanied by a certified check, a cashier's check, or by a bid bond executed by a corporate surety satisfactory to the Casitas Municipal Water District, in the sum of not less than ten (10) percent of the total amount of the bid for the initial contract items list, as a guarantee that the bidder will enter into the proposed contract, if it be awarded to them. The guarantee will be forfeited, should the bidder to whom the contract is awarded fail to enter into the contract.

Replace Bidder's Bond in its entirety with the attached Bidder's Bond.

Replace the bid schedule on pages 17 and 18 with the attached bid schedule.

Item AD2-6

Part D: Measurement and Payment – Bid Schedule Item No. 17 – Water Line Under-Crossing

Add paragraph on page 75:

Bid Schedule Item No. 17 – Water Line Under-Crossing.

The work under this item shall include the cost of crossing under existing utilities (for trench depths between 5 feet and 8 feet) where fittings are required, not limited to excavating, shoring, furnishing and installing piping and appurtenances and transitioning back up to normal trench depth, and all other labor, equipment and material incidental to the crossing of existing utilities that cannot meet the minimum separation requirements set forth in the plans, complete in place.

Full compensation for completing Water Line Under-Crossings including all labor, equipment, materials, tools and incidentals, and for conforming to all applicable provisions of the Standard Specifications, these Special Provisions, and the requirements of the District, shall be considered as included in the price of Bid Item 17 paid for each location, complete and in-place, and no additional compensation will be allowed therefor.

Item AD2-7

Questions

Question 1: Is it the intent of the agency to install a temporary high line for this project or to leave the main active and install tie-ins after testing?

Response 1: The District anticipates the tie-ins can be completed once the new main is live and tested. A suggested sequencing has been outlined in Part E of the bid documents. The District is not opposed to high lining if the Bidder feels it is more economical to do so. The cost of the high line will be solely at the Contractor's expense.

Question 2: Can the Contractor place plates over the trench and put cold mix around plates during trench excavation after work hours?

Response 2: Trench plates with cold mix is acceptable. Recessing plates are not necessary.

Question 3: Can the Contractor close the street from one intersection to the next so we can install the waterline and services and only residents have access to the closed road?

Response 3: Yes, the City has indicated this is acceptable. Approval pending encroachment permit requirements.
