Instructions

In addition to the attached requirements, applicants must be income qualified. The Monthly Income represents the Total amount of GROSS income for ALL ADULTS in the Property Owner's household for the month the application is submitted. (Program qualification depends on INCOME and does not consider assets.) Number of residents per household represents ALL members of the Property Owner's household.

“Solar for All California” and Weatherization Program Requirement

Applicants must meet income guidelines

Roof must be in GOOD REPAIR

Property must have “solar access” (free of trees around roof)

Roof must be pitched

Property owner authorization required

“Solar for All California” is available outside Sonoma County

- Homes that are drafty with high heating & cooling bills will receive maximum weatherization implementations.
- Mobile or manufactured homes will not qualify

FREE Weatherization *Includes**

Free Energy Assessment

“Weatherization” typically saves \$437 annually in heating & cooling bills.

Weather-strip, caulk, insulate attics & floor, crawlspaces, ducts & water heaters

Windows & Doors

Shade screens, interior storm windows, replacement windows & doors.

Appliance, Equipment & HVAC replacement can save an additional \$130 each year. Refrigerator (pre-1992), microwave, heating systems (inoperable), cooling systems (inefficient), water heater, timers, lighting, exterior lights, low-flow shower heads and faucet aerators.

Weatherization packages can be valued at up to **\$6,500** per house and can save 2.65 Metric Tons of CO₂ for the life of the weatherization.

*Eligible measures identified with Free Energy Assessment. Only program eligible measures will be installed on a case-by-case basis.

SCEIP Financing Information

For improvements beyond those provided above, financing is available to property owners for eligible Energy & Water Efficiency Measures through SCEIP. These improvements must be permanently attached to the property. Financing is provided at 7% interest and repaid through property taxes. **Eligibility requirements include:**

- Current on Taxes
- Current on Mortgage
- Not in Bankruptcy
- No Involuntary Liens
- Lien to Mortgage Value cannot exceed 100%
- Improvement equal to, or less than 10% of property value
