OVERVIEW

The Lindsay Maxwell Charitable Fund Washington International Horse Show Equitation Finals are a highlight of the Washington International show week for junior riders, and are a proving ground for future grand prix and Olympic riders. Riders compete throughout the year to earn points to compete in the Finals.

The grant is not strictly monetary in nature but rather experience-based. The grant recipient will have their expenses paid by the Lindsay Maxwell Charitable Fund. See covered expenses below.

The grant will give a rider the opportunity to participate in the Lindsay Maxwell Charitable Fund WIHS Equitation Finals without the financial burden that accompanies this prestigious event. This grant is generously sponsored and created by the Lindsay Maxwell Charitable Fund.

APPLICATION

Any WIHS member may apply for the grant. Individuals under 18 must have signed parental consent. Each application must include:

- A completed application form
- A letter from applicant detailing their interest in the grant and why they should be considered for selection
- Three letters of recommendation from teachers, employers, coaches or trainers and/or those you reported to during
 your community service. Letters must not exceed one page in length and should detail applicant's background, achievements, examples of leadership and community involvement. One letter must be from the applicant's trainer(s).
- Financial need documentation. Accepted documents include: FAFSA and most recent tax return. All financial information is intended confidential for review only by the WIHS & Lindsay Maxwell Charitable Fund Review Panel.
